Melissa Tomlinson, Consulting CFO, reviewed the financials from month ending July 2023. These documents were reviewed and approved by the Finance Committee last week.

July was another very strong month, although we were a bit under budget on the revenue side. That was matched by expenses being a bit under budget as well.

Program revenue was under budget, and as we've discussed in prior summer months, camp registrations came in lower than anticipated.

We anticipate that we will end the year in a positive position with respect to the operating budget, when we had anticipated that we would end the year in a negative position.

Our Balance Sheet is also very strong.

## **Preliminary FY2024 Update**

The preliminary budget was shared and discussed. This budget was reviewed in depth and vetted last week with the Finance Committee. Key factors that went into the FY24 proposed budget is the decision to keep the price of cookies at \$5/box for the upcoming 2024 Cookie Season with a planned price increase to \$6/box in the 2025 Cookie Sale. While we are proposing a negative budget, it's negative by less than 1% (without depreciation and NGSRP). The price increase in 2025 will eliminate that budget gap.
